Works with supervisor to ensure all work carried out by subordinates adheres to, and is in compliance with all Corporate Departmental and Divisional safety policies/procedures including compliance with WorkSafe BC regulations. Advises supervisor of situations requiring review. Assists in the development of all safety documents and reports for each assigned project.

Assures best construction practices are used to minimize impact to the environment

Uses computer applications related to the position and duties.

Trains subordinates in current construction practices and procedures and monitors to ensure training objectives are being met.

Trains and develops employees by:

- Providing orientation and on the job training of staff. Recommends areas of developmental training
- Assuring all required safety training is up to date, identifies and coordinates any additional training that may be required. Encouraging and supporting staff to pursue additional related training courses/seminars (both internal and external)
- Providing opportunity for staff to gain experience in all areas of the systems and related processes.
